## **University of Cincinnati Award**



**Dr. Kelly Dedel** One in 37 Research, Inc.

Kelly Dedel, Ph.D. is the Director of One in 37 Research, Inc., a criminal justice consulting firm based in Portland, Oregon. Although most of her work requires travel to other states, she has had several recent opportunities

to work for "the home team." In 2005, she completed a validation of Multnomah County's Juvenile Detention Risk Assessment Instrument (RAI). This study permitted the County to further its commitment to being a data-driven organization and catalyzed important changes in the profile of the detention population. Most importantly, the revised RAI has produced improved public safety outcomes among youth who are released. In 2007, Dr. Dedel conducted a validation of Multnomah County's adult jail "Recog Tool," used to determine which offenders can be safely released on their own recognizance. In large part, the study confirmed that the original constellation of factors correctly identified the lowest risk offenders. The County continues to use the Recog Tool in its original form. When not working in Oregon, Dr. Dedel consults with various States and the U.S. Department of Justice to reform the conditions of confinement in juvenile detention and correctional facilities. Her areas of expertise include protection from harm, suicide prevention, special education and quality assurance.

## Sam Houston State University Award

Michael Ostermann was awarded the degree of Doctor of Philosophy in May 2009 from the Graduate School of Newark at Rutgers University. Dr. Ostermann is currently employed as a research scientist in the Office of

Policy and Planning at the New Jersey State Parole Board. In this position Dr. Ostermann leads the Board's research efforts and acts as the agency's primary data and evaluation coordinator for both the Governor's Another Chance Reentry Initiative under the Safe Streets and Neighborhoods Anti-Crime Plan as well as the Government Efficiency and Reform Committee.

Dr. Ostermann recently completed an evaluation of the efficacy of the State Parole Board's residential and non-residential community programs. The article that was produced from this research appeared in The Journal of Offender Rehabilitation and is entitled "An Analysis of New Jersey's Day Reporting and Halfway Back Programs: Embracing the Rehabilitative Ideal through Evidence Based Practices." This research report highlights the utility of enhanced parole supervision with community programs in comparison to general parole supervision and no post release parole supervision. Results from this study significantly impacted statewide reentry practices and the article has been awarded the Sam Houston University Award from the American Probation and Parole Association.

### Juvenile Justice Crime Prevention Act

Felicia Cotton currently serves as the Chief for the Juvenile Special Services Bureau of the Los Angeles County Probation Department. Her responsibility includes oversight of eight major operations consisting of over 700 employees: Intensive Gang Supervision, Special Enforcement Operations (Armed Probation Officers), Camp Community Transition Program, Juvenile Justice Crime Prevention Act Programs, Intake and Detention Control, Court Officers Program, Community Detention Program, and Operation Read serving over 12,000 probation and at-risk youth annually. She serves as the Chair (representing the Chief Probation Officer) of the County of Los Angeles' Juvenile Justice Coordinating Council, the governing body for juvenile justice programs and grants. She is responsible for maintaining the Department's Juvenile Justice Crime Prevention Act (JJCPA) programming, which consists of 12 programs, three initiatives and over 40 funded partners. Further, she developed a training academy for JJCPA Probation staff and Community-Based providers that builds capacity to service families in a more comprehensive manner.

Ms. Cotton has enjoyed a very rewarding career serving youth and families through the County of Los Angeles for the past 22 years. She has been responsible for designing and implementing various "cutting edge" programs throughout her career with the Department, including the JJCPA School-Based Supervision and Housing-Based Supervision Programs. School-Based Supervision provides prevention and intervention services to Probation and at-risk youth at over 130 school campuses in high crime/high need areas. The Housing-Based Day Supervision Program provides case management, day supervision and family intervention initiatives for Probation and at-risk youth and their families at eight public housing sites.

### "Supporting Operational Goals Through Internet Podcasting"

The Court Services and Offender Supervision Agency (CSOSA) is a federal, executive branch entity providing parole and probation services for Washington, DC. CSOSA began offering television and radio shows under the title of "DC Public Safety" in January 2007. A blog (articles) and transcripts were added in 2008. All podcasts can be accessed directly from http://media.csosa.gov.

CSOSA now has the highest ranked social media program for criminal justice issues in America (per Google). They have the highest ranked blog for public safety issues (per Google) and have been called a "national model for communication" by an international criminal justice association. In addition to being a resource for major national websites including: National Public Radio, the Department of Justice and the U.S. Government's primary web portal, the site was declared a top ten web site by Government Computer News Magazine in 2008. As of February of 2009, the site has received over 1.5 million requests.

Leonard A. Sipes, Jr., is the Senior Public Affairs Specialist, and Mr. Barnes currently serves as the Enterprise Director for Information Technology for CSOSA. CSOSA's podcasts have greatly enhanced the agency's ability to communicate its activities and connect with the public. Because Mr. Sipes and Mr. Barnes taught themselves how to podcast and set up an inexpensive recording studio to generate and edit the material, they have realized a substantial return on a very small investment. Through their efforts, they have shown extraordinary initiative, innovation and dedication to ensuring that the agency's message reaches the widest audience possible.
